COLLECTION OF YOUR PERSONAL INFORMATION

To better provide you with products and services offered on our Site, Recovery Café Clark County may collect personally identifiable information, such as your: If you purchase Recovery Café Clark County's donation services, we collect billing and credit card information. This information is used to complete the purchase transaction.
